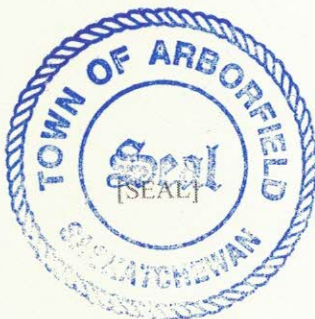

BYLAW NO. 2015-02

A BYLAW TO CONTROL THE OWNERSHIP OF ANIMALS IN THE TOWN OF ARBORFIELD

The Council of the Town of Arborfield in the Province of Saskatchewan enacts as follows:

1. This bylaw may be referred to as the "Animal Control Bylaw".
2. For the purpose of this bylaw, the expression:
 - a. "cattery" shall mean a place where cats are bred or looked after;
 - b. "dovecote" shall mean a structure for housing pigeons;
 - c. "fur farm" shall mean a place where animals are bred for fur;
 - d. "kennel" shall mean a breeding or boarding establishment for dogs;
 - e. "livestock" shall mean cattle, goats, llamas, alpacas, sheep, swine, deer, antelope, horses, donkeys, or mules in the singular or plural;
 - f. "poultry" shall mean domesticated birds including chickens, turkeys, ducks, geese, quail, guinea fowl, grouse, pheasants, partridges, pigeons or ostriches in the singular or plural;
 - g. "Domesticated pets" shall mean cats, dogs, hamsters, guinea pigs, tame mice, chinchillas, rabbits, reptiles, amphibians, snakes, birds or other small caged animals.
3. No person shall herd, graze or otherwise keep livestock or poultry at any time within the limits of the Town of Arborfield.
4. No person shall have a cattery, dovecote, fur farm or kennel at any time within the limits of the Town of Arborfield.
5. No person shall keep more than 6 domesticated pets in aggregate within the limits of the Town of Arborfield except in the case of a temporary fostering or boarding situation when permission from council has been granted.
6. Any person found guilty of an infraction of any of the provisions of this bylaw shall be liable to the penalties provided in the General Penalty Bylaw of the Town of Arborfield.
7. Read a third time and adopted this 14 day of DEC, 2015

BYLAW NO. 2016-005

A BYLAW OF THE TOWN OF ARBORFIELD TO AMEND BYLAW NO. 2015-02
THE ANIMAL CONTROL BYLAW

Council of the Town of Arborfield, in the Province of Saskatchewan, enacts as follows:

1. THAT **Section 6)** of Bylaw No. 2015-02 as enacted on December 14, 2015 is repealed and the following substituted therefore:

"6) Any person who contravenes any provision of this bylaw is guilty of an offence and liable on summary conviction:

a) to penalties as follows:

i. \$1,000 in the case of an individual; or


ii. \$2,500 in the case of a corporation;


and

iii. in the case of a continuing offence, additional penalties of \$100 per day for an individual or corporation for each day or part of a day during which the offence continues;

to a maximum of \$5,000 in aggregate."


Read three times and adopted by Council of the Town of Arborfield in the Province of Saskatchewan this 21 day of JUNE, 2016.
